1. In order to purchase a parking permit, a **STUDENT MUST PRESENT A VALID DRIVER'S LICENSE AND LEGAL VEHICLE REGISTRATION** WITH THEIR COMPLETED APPLICATION. These must be provided at time of purchase.
2. All student vehicles parked in the high school parking lot are **required to be registered and to display a FHS parking permit**. The parking permit fee is \$30.00/year or \$15.00/semester.
3. Students may park, during school hours, in the north student lot, the south student lot or the southwest student lot. Students may not park in the teacher/visitor areas in front of the building, on the west side of the building by the small gym, or in the lot near the science wing.
4. Upon arrival to school, **students must enter the building immediately**. No Loitering!
5. **Students are not allowed to return to their cars** during the school day without permission.
6. Students must **drive in a safe manner**. Any reckless display of driving or driving at an unacceptable rate of speed will not be tolerated. Violators are subject to loss of driving privileges and/or involvement by Flushing Township Police.
7. **Flushing Community Schools assumes no responsibility for the student vehicle or its contents**.
8. Selling, lending, duplicating or giving a permit to any other student is not permitted.

I have **read, understand, and agree** to abide by the FHS student parking regulations. Further, I take **full responsibility** for my actions and understand that my failure to follow these guidelines may result in **loss of parking privileges, towing, disciplinary action, and/or involvement by Flushing Township Police**.

PARKING GUIDELINES – Students are to understand that driving to school is a privilege that, if abused, may be taken away. Student drivers are reminded that vehicles parked in the school’s lot are subject to search if there is reason to believe that drugs, alcohol, stolen property, or other contraband might be present.

Student parking is provided in the north student lot, the south student lot to the east of the auditorium, and the southwest student lot, to the west of the auditorium. There is to be **NO** student parking in the west lot of the small gym area, in the teacher lot, or in the front of the building in the teacher/visitor lot. Once the school day begins, the parking lots are “off limits” to students unless they have a special pass for co-op or a have a specific pass from the attendance office indicating that they have permission to leave campus.

- Parking Fee: \$30 per year or \$15 beginning of second semester. Checks are to be made payable to Flushing Community Schools. A receipt will be given to the student upon payment of parking fees.
- Payment & registration form will be turned in to the secretary in the guidance office.
- All students must be licensed and covered by insurance. Flushing Community Schools is not responsible for either the vehicle or its contents.

Violations

- Parking in the teacher/visitor lot in the front of the building.
- Parking in the teacher lot west of the small gym.
- Parking in the teacher lot near the science wing.
- Parking on school grounds without a permit.
- Improper parking (i.e. across any line, etc.)
- Selling, lending, duplicating, or giving their permit to any other student.
- Students must drive in an acceptable and appropriate manner at all times. Any student driving in a careless or negligent manner will be subject to the loss of parking privilege and/or involvement by Flushing Township Police.
- Upon arrival to school, students must enter the building immediately. Loitering or gathering in the parking lot will not be permitted. Students may not return to their vehicles until dismissed from school or have permission from the attendance office.

Consequences
